WHAT HAPPENS WHEN I SUBMIT THE ONLINE REGISTRATION FORM?

When this form is submitted you will receive an automatic confirmation email to notify that we have your basic details completed on our online registration form. You will be sent and/or emailed the Business Membership Form or Business Search attachment and Website TERMS OF USE. Your Membership form must be read, completed and returned to us for pending Membership approval. On approval of your membership the details you have completed will be loaded to the website to form your Business Page (BUSINESS SEARCH MEMBERSHIP ONLY)

WHO CAN REGISTER FOR BUSINESS MEMBERSHIP and BUSINESS SEARCH MEMBERSHIP?

Only the Business Owner or person authorised to book advertising and authorise payments on behalf of the business owner may register to use our service – **our terms of use include**

- The business you are registering is located in or provides a Service to households or businesses located within the City of Wanneroo and Joondalup. Business trading location/postal address must be located within the Perth Metro Area.
- You are over the age of 18 years and you are able to enter into any legal agreement.
- · You do not falsely state, impersonate or otherwise misrepresent yours or the businesses identity.
- The business you wish to register is not unlawful does not promote adult only services and will not at
